Hello, Corvette Club of Iowa members,

It is odd how things sometimes play out to make a story that someone may find interesting for our club members. This month, it will start with a story about a recent trip. A few weeks ago, a few members of the club had a great time driving to and around the Lake of the Ozarks. We got to drive around on some of the curvy roads, visited a distillery/brewery, and had a great time socializing. One stop that many of us were thrilled about was how Dave had arranged for us to go to and make some laps around the Ozarks International Raceway. Maybe some of you had heard of it before, but I had no idea that within a days drive, I would be able to see and drive on a track that had many horizontal and vertical curves, that also seemed to wind through country roads, not seeing anything but the cars in front of you, the apexes, and the trees lining the raceway. General Meeting Minutes

April 18, 2023

The general meeting of Corvette Club of Iowa was called to order at 6:47PM on April 18, 2023 at Central Iowa Corvette in Clive. Board President Carroll McCracken was present and welcomed 4 new members and had them introduce themselves to the group. Carroll also was saddened to report Dave Howard had an accident in his 74 Corvette on the way to the April board meeting. The car ended up upside down and he was injured fairly significantly. He was in ICU and was intubated so he is currently unable to have visitors. His wife Mert will keep the club updated and let us know when he can have visitors. Secretary Dave McChesney reported that the General Meeting minutes are published in Sportsmate, Carroll sent out a different version due to Dave's situation. He reported the bylaws committee has met and further discussion will be had regarding that during old business. Motion to approve minutes made by Debbie Mahon. Dave Brown seconded. Motion Passed. Treasurer Steve Rahn was present and reported starting and ending account balances in the various accounts. Sponsorship renewals were received from Karl Chevrolet and Willis Chevrolet in Granger. We have officially purchased the new hardware for the race timing and it has arrived. Dave Brown donated two PCs and those are being configured and set up. Motion to accept the Treasurer's report made by Gary Foster. Seconded by Jeff Jackson. Motion Passed. Vice President/Social Director Dave Brown reported an event coming up headed to Lake of the Ozarks area. Paragon Performance in Waukee has invited the club to attend their Cars and Coffee event as well. Other opportunities are in the works in the coming months. Governor Gary Foster was present and reported we are looking forward to a good turnout for the Memorial Day Autocross. West Region has it posted on the website. Competition Director Mark Cooper discussed work groups for the event and signing up for worker shifts. There is another Governor's meeting the first weekend in May and he will be attending. Memorial Day event will 7 events per day, over three days for a total of 21 events. Pat Whalen made a point to highlight that members that have never competed are encouraged to come out and drive at the autocross and experience autocross. The course can be driven at any pace you choose. Organization of the corner worker schedule and work shifts is being sorted out. Member at Large Jeff Jackson was present and reported he is waiting to hear back from a few places for having monthly meetings. Jeff conducted the 50/50 raffle Tony Di-Maio won the raffle. Editor Dave Howard was unable to attend and Nichole Parnell volunteered to handle the Editor duties while Dave is on the mend. Points Director Laurie McCracken was present and reported points are in order and she is having difficulty getting the audit together as she is unable to drive to Des Moines physically. Membership Director Mike Golightly reminded everyone to grab cards to hand out to perspective members. We have added 3 additional members in the past month. Social media director Pat Whalen reported he has been remiss about getting photos up on the site from Wayne. He now has the ability to get those posted himself and a big thanks to him for taking that on.

Old Business: Dave Vance reported the track event at RPM is being bumped slightly to July due to a scheduling conflict at the track. They are excited to have us there and more information will go out by email as it unfolds. New Business: Bylaws committee report was submitted to the club by Dave McChesney. Hard copies were provided for members. 5 key items were outlined for recommended changes. The first is regarding the registered agent for the club. The recommended change is to specify a club officer as registered agent in order to ensure we are in compliance with State of Iowa rules. The second key recommended change is to add a paragraph to the bylaws that specifically references the Supplemental Rules as being part of the bylaws and renames those rules to Standard Operating Procedures. The Third recommendation is to change the legal disclaimer to a more specific statement that is more on track with current legal language in bylaws and contracts. The general idea is that if any part of the document is declared invalid it does not invalidate the entire document. The fourth key change recommended is to change the language regarding the use of club member personal information by club members. It states that now specifically the use of club member personal information for commercial purposes or other inappropriate way, that member can be expelled from the club. The fifth key item recommended is a change in the language regarding the calculation of the funding of the charity fund. The recommendation is to simplify the calculation to make it so that 10% of the club's total fund on December 31 st is added to the charity fund, rather than adding funds to make it 10% of the club's total funds. The reason behind this change is to ensure that the money intended to go to charitable giving that is collected throughout the year does not offset funds that would otherwise go into the charity fund at the end of the year. A number of other small clerical changes are recommended, essentially grammatical and formatting. Gary Foster asked a question regarding the reasoning behind changing the Supplemental Rules to Standard Operating Procedures. The change does not align with NCCC formatting regarding section. Discussion was had regarding this and the decision was made to not make that change and ensure that the section matches the NCCC name for this section. Mike Golightly brought up that the language regarding lifetime membership does not match NCCC policies. The NCCC rules state that a person can purchase a lifetime membership after 1 year of membership, essentially immediately. The club rules state a member must have 10 consecutive years of membership before they can purchase a lifetime membership. Discussion occurred regarding revenue issues potentially and other issues. The question is how much should a lifetime membership cost if we make the change? NCCC dues for a lifetime membership is 10 times annual dues. If the club mirrors that policy, \$200 should be the price to purchase a lifetime membership to CCI at the club level. A lifetime membership to NCCC would be required as well, since membership in CCI requires an NCCC membership. A total of \$560 would be required to become a lifetime member at both levels at once. A clarification was made that NCCC calls their rules "Standing Rules, Policies, and Procedures" and the recommendation is to change Supplemental Rules to match that. A motion was made by Gary Foster to "accept the bylaw changes as written, except to change the wording of the Supplemental Rules name change to mirror NCCC wording, and that we add the terminology we discussed regarding lifetime membership for CCI members" Steve Rahn seconded the motion. The motion passed. Changes will be published in the May Sportsmate for final vote at the May meeting. Motion to adjourn the meeting made by Debbie Mahon. Meeting was adjourned at 8:37PM.

From the Governor...

Hi, Everyone:

It's May! According to the old adage, that means we reap the benefits of April showers with lots of May flowers. This is also the month for this year's version of the Flying Low in 2023 low-speed autocross. April rain was one thing, but we can do without any showers for the racing over the Memorial Day Weekend at the Ankeny Regional Airport. Competition Director Mark Cooper and the entire committee have done a great job this year planning for our event. I hope that you will come by and check out the competition. You can grab a helmet and be a participant, help us out by being a worker, or just see what an autocross is all about.

I recently attended the NCCC Governors' Meeting in St. Louis. I wasn't alone. If you didn't already know, the Governor is Corvette Club of Iowa's representative at these quarterly meetings where decisions are made pertaining to the operation of all NCCC clubs. Additionally, the United States is divided into regions, with each club fitting into an NCCC region. CCI is one of 17 clubs in the West Region. The region further oversees its clubs and may further define how its events are held. In addition to the Regional Executive (RE) and the Regional Competition Director (RCD), the regions all have a Regional Membership Director (RMD), a Secretary, and a Treasurer. CCI is well represented in the West Region with Nan Brittain, as RMD; Sheila Wyman, as Secretary; and Linda Hommer, as Treasurer. Denny Luther serves on the National Executive Board as Parliamentarian, who manages the REs, and is in charge of NCCC's by-laws and Standing Rules.

Business dealt with at the April Governors' Meeting included the following items:

- There are currently 18,241 NCCC members
- NCCC has welcomed several new clubs, recently, including those from California, West Ohio, and the Northeast Region
- It was announced that there were 750 people registered for this year's Annual Convention in Bowling Green, KY
- There will be 3 new by-law changes proposed at the September meeting
- The Executive Board requested that retiring E-Board members have their terms extended for one meeting to help train the new officers who are replacing them
- Governors were reminded that our insurance coverage remains in jeopardy. It has been stressed that safety is very important during our events.
 - The insurance waivers at our events MUST be signed individually by each party. It is not permissible for a person to sign for another person.
 - For competitive events, we are only permitted to use the waiver with the legal description printed on it. This is the page that is half full of legal wording followed by room for ten signatures. Each signature must be witnessed by the person who signs off as a witness. We can no longer add blank pages that just has lines to sign.
 - It was determined that competitors must sign a new insurance waiver at an event for each day. So, for a two-day weekend, you'll have to sign two waivers. One for Saturday and one for Sunday.
 - Another issue regarding insurance was that Non-Corvette competitors at a speed event can sign to join NCCC as an Enthusiast member (Don't have to own a Corvette, cannot hold office, and receive no competition points) and receive the same insurance coverage as an active member.
- The RCDs discussed a proposed change to allow a competitor to ride with another competitor during a low-speed autocross. The reason for this is to help a novice participant learn how to get around the course properly or to improve his/her autocross skills.
- There was a change to obtaining points for Fastest Time of Day. This pertains to classes where there are no other competitors. Instead of awarding the only competitor points for FTD, it was determined that to earn those points, you had to beat another competitor in the class.



From the Governor... (Continued)

- East Ohio is hosting a speed event at the National Corvette Museum (NCM) track before convention
- Traditionally, the Annual Top Men's and Women's Competitor have been awarded a gold ring for their accomplishment. Gold prices have risen during the past year, to the point that the budgeted line item for that expense was \$4,000 short. The Board of Governors voted approve adding \$4,000 to the line item to purchase the two rings this year. However, this will be the last year NCCC Top Competitors will receive gold rings.
- The new E-Ray and Z06 will be in the PP class with the C8 Corvette for competitive events
- There was much conversation about the E-Ray, and whether or not it was banned from competing in NCCC events. The short answer is NO, it is not banned, and it may compete in our events. (For the record, it was never supposed to be banned in the first place). The intention was to ban Electric Vehicles (EVs) due to the propensity of their batteries to burn very hot, if they catch fire, to the point fire departments can't put out the blaze. This represents a dangerous situation, and one that, in addition to endangering persons at the event, could result in significant damage to the event site. One E-Board member apparently misunderstood and interpreted EV to include Hybrid vehicles. The E-Ray is technically a hybrid, not an EV. The ban on EVs and Hybrids was lifted, and will be left up to the event host to determine whether or not to allow them at the events. However, it is not recommended that EVs be permitted to participate.
 - Right now, for concours events, the engine in an E-Ray will not be judged (you can't get to it)
 - There is discussion as to how to complete technical inspection on the E-Ray for a speed event. They are still working on some of these issues.
- NCCC Charity Director was presented with a \$1,000 check from CCI for St. Jude Children's Hospital
- West Region was presented with a \$750 check from CCI for the West Region Scholarship Fund
 - Note - The WR Scholarship Committee is accepting scholarship applications until August
 - You can find more information and download the application at the WR Website www.westregionnccc.com.

It was a busy weekend, and I may have missed something that was discussed. However, this should give you an idea as to what's going on at the National level. I hope to see you all at our Flying Low in 2023 autocross later this month.

By-Law Review

The last step in the annual process of amending our By-Laws, a vote on proposed changes, takes place at our May general meeting. Discussion of these changes occurred during April's meeting. We will be voting on the changes in their entirety. A 2/3 majority vote in favor approves them. A complete transcript of the changes follows.

BY-LAWS

Date Last Revised: 05/4/2023

CORVETTE CLUB OF IOWA, INC.



ARTICLE 1 – NAME -PURPOSE-LOGO

SECTION 1: The name of this Club shall be Corvette Club of Iowa, Incorporated.

SECTION 2: The purpose of this Club shall be the furtherance of interest in Corvettes and related activities.

SECTION 3: The Club's logo shall be a design of a "Corvette" steering wheel on which shall be inscribed the words "Corvette Club of Iowa," and CCI as shown below.

SECTION 4: Corvette Club of Iowa colors shall be red, black, gray, and white.



ARTICLE 2 MEMBERSHIP

SECTION 1 - Qualifications:

Membership in the Corvette Club of Iowa (CCI) shall be limited to owners or operators of Chevrolet Corvette motorsports vehicles who are also members in good standing with the National Council of Corvette Clubs (NCCC) and the West Region, except as otherwise provided in these By-Laws. Applicants must be eighteen years of age or older (except a dependent member). All membership applications must be submitted to the Treasurer and Membership Director.



SECTION 2 - Definition:

- A. Individual Member- A member of CCI.
- B. Enthusiast Member- Corporations, businesses, or individuals related to the promotion of the Corvette automobile or CCI.

SECTION 3 - Classification:

Members shall be classified as follows:

- A. Primary Member- Each applicant for Primary membership shall furnish proof of compliance with the requirements outlined in Section 1 of this article. (Via completed and signed application). Upon receipt of all CCI, West Region, and NCCC fees and dues; and upon approval by the CCI Board of Directors

By-Law Review (Continued)

A-B. _____, The applicant shall become a Primary member of CCI. Every Primary member must comply with the requirements outlined in Section 1 to be eligible to continue as a Primary member of CCI.

B-C. _____ Spouse/Companion Member- The Spouse or Companion of any Primary member whose mailing address is the same as the Primary may become a member of CCI upon payment of all CCI, West Region, and NCCC dues and fees. The member shall be entitled to all privileges of Primary membership.

C-D. _____ Youth Member- A person sponsored by a Primary member who is between the ages of 16 and 21 years of age, or between the ages of 16 and 25 and also a full-time student, whose mailing address is the same as the Primary shall become a member of CCI upon payment of all membership dues and fees equal to those of Spouse/Companion membership. They shall be entitled to all rights and privileges of Spouse/Companion memberships, except the right to hold an elected CCI office, and may not "chair" a sanctioned or unsanctioned event.



D-E. _____ Life Member- To qualify, the applicant must currently be a Primary Member of CCI and must have been a Primary, Spouse/Companion, or Youth Member (or any combination) of the CCI and NCCC for at least ten (10) consecutive years. The dues for this classification of membership shall be the current NCCC Life Member dues and ten times the current CCI and West Region dues. Life members shall be entitled to all rights and privileges of a Primary Member. Application for this classification of membership must be unanimously approved by the CCI Board of Directors.

E-F. Associate Member- This classification of membership is available to former CCI members who do not currently own a Corvette. Associate Members must be members of CCI, West Region, and NCCC. They have the same rights and privileges as Primary Members, but may not hold elected offices or compete for Regional or National points. Dues and fees shall be equal to those of a Primary Member.

F-G. _____ Enthusiast Member- The Treasurer or Membership Director may accept applications for Enthusiast Members. Dues shall be equal to those of a Primary Member's CCI dues only. Enthusiast Members shall not be entitled to vote, hold any offices, or compete for CCI, Regional, or NCCC points. Enthusiast Members need not comply with the Corvette ownership requirement outlined in Section 1 of this article. All other provisions of Section 1 of this Article shall apply.

SECTION 4 - Transfer of Membership:

Membership in CCI is not transferable or assignable.

ARTICLE 3 DUES

SECTION 1: Initial dues of the CCI shall be accepted anytime during the year. Renewal dues shall be due on November first (1st) each year. Initial or renewal of National Council of Corvette Club, Inc. dues shall be outlined in the Articles of Incorporation, By-Laws, and Standing Rules of the organization. Dues shall be delinquent after November first (1st). Dues for new and renewing members are subject to change as a result of the annual dues review.

SECTION 2: Those wishing to join after the August General Membership meeting will pay current year dues which will cover the remainder of that year plus the entire following year.

SECTION 3: The dues to be assessed for membership in CCI will be reviewed each year in July by a Dues Review Committee composed of the Treasurer, Member at Large, and one full voting non-Board member.

They will make their recommendation to the Board of Directors (Board) at the August Board meeting. The Board will make its recommendation to the membership at the August General Membership meeting. The Board's recommendation will be accepted or rejected at the August General Membership meeting.

ARTICLE 4 - OFFICERS, APPOINTED BOARD MEMBERS, THEIR DUTIES, AND TERM OF OFFICE

SECTION 1: The elected Officers of this "Club" shall be: President, Vice- President, Secretary, Treasurer, and Governor (Clubs' representative to NCCC).

SECTION 2: The appointed Board members of this club shall be: Editor, Competition Director, Points Director, Membership Director, and Social Media Director. Appointed Board members are encouraged-expected to attend monthly Board meetings.

SECTION 3: One elected Member at Large shall also serve as a Board member.

SECTION 4: The Club will appoint one officer to be the Club's One-appointed Registered Agent.

SECTION 5: Duties

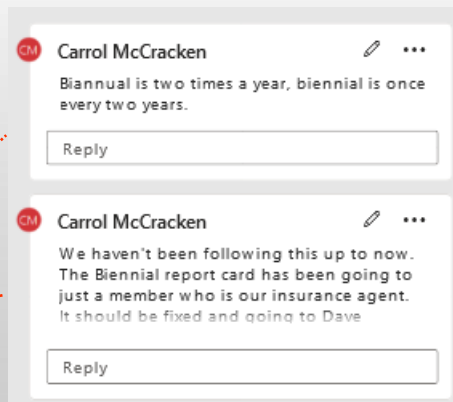
- A. The duties of the President are to preside at meetings and to act as the official officer for any club meetings. The President has the responsibility of conducting the meetings according to "Roberts Rules of Order". The President has the right to call any special meetings considered necessary. Proper notice of special meetings shall be given at least three (3) days in advance. The President is responsible for supervising and coordinating



By-Law Review (Continued)

the activities of all elected Board members. The President is to ensure elected officers fulfill their obligations and appoint committee chairpersons and members promptly. The President should verify who the Registered Agent is annually. The name will be published on the website and in the Sportsmate.

- B. The duties of the Vice-President are to preside in the absence of the President and to supervise the club's social activities, Editor and [Social Media Director](#). Also, social events where points will be awarded will be presented to the CCI Board for approval. The Vice-President is responsible for appointing members to the Treasury Audit Committee.
- C. The duties of the Secretary are to take minutes at the meetings and retain all important documents. The Secretary is also responsible for the supervision and coordination of the activities of the Rules and By-Laws Review Committee, Balloting Committee, Officer Nomination Committee, and CCI's Corporate Agent. The Secretary is also responsible for the maintenance of CCI's Articles of Incorporation, ~~biennial~~ ~~bi-annual~~ report receipt from the Iowa Secretary of State, and current CCI By-Laws and Supplemental Rules.
- D. The duties of the Treasurer are to be responsible for all monies, bills received, and all property ~~owned for resale, and all property not for resale~~. The Treasurer supervises the Dues Review Committee and oversees the distribution of dues renewal notices. The Treasurer is also responsible for supervising the activities of the Property Inventory Committee and the Advertiser Fee Structure Review Committee. The Treasurer is responsible for maintaining a permanent record of all financial records, club checkbook, property inventory listing, and annual insurance and license on the club trailer. The Treasurer or his/her designee is also responsible for all tax filings of the club. Tax filings for the club are completed on a calendar year basis.
- E. The duties of the Governor are to report NCCC activities, attend NCCC meetings, collect NCCC dues, and issue NCCC membership materials. The Governor shall also be responsible for supervising the Points Director, Membership Director, and Competition Director. The Governor coordinates the activities of the Points Audit Committee, Competition Committee, and the Awards Banquet Committee.
- F. The duties of the Editor are to compose and publish the Club newsletter. The Editor is also responsible for retaining paper and/or electronic copies of all club newsletters and all ad copies. The Editor is accountable to the Vice-President and is a member of the Advertiser Fee Structure Review Committee.
- G. The primary duty of the Competition Director is to administer the competition program for the club. The Director may be assisted by a three (3) member Competition



Committee. The Director is accountable to the Governor. The Competition Director will be responsible for all procurement and distribution of trophies.

- H. The duties of the Points Director are to record and keep records of all club and NCCC points earned by members during the competition year and publish current point standings. The Points Director is accountable to the Governor.
- I. The primary duty of the [Social Media Director](#) is to administer CCI's social media sites and be the primary point of contact for the website administrator. This person is also responsible for updating CCI's calendar on the website and dissemination of club email notices. The [Social Media Director](#) is accountable to the Vice-President.
- J. The duties of the Membership Director are to promote activities that retain current members, recruit qualified new members and act as a liaison for new members and guests at club functions. Additionally, the Membership Director is responsible for maintaining blank membership applications, providing welcome materials for new members, and publishing and maintenance of the club's membership roster. The membership roster will be posted to the CCI website on the Members Only page in January, June, and November, and a new member listing published monthly in the Sportsmate. The Membership Director is accountable to the Governor.

The duties of the Member at Large are to represent the interests of the membership at Board meetings. Specifically, the Member at Large is to act as a liaison or means for members to present issues to the Board. The Member at Large is also responsible for promoting club goodwill and other duties as assigned to them by the President. The Member at Large is responsible for securing meeting sites for all Board and General Membership meetings. This officer is also responsible for conducting 50/50 drawings and ensuring the Treasurer receives 50% of the drawing proceeds for deposit in the Charity Fund. The Member at Large is a member of the Officer Nomination Committee, Awards Banquet Committee, and the Dues Review Committee.

- K. The Registered Agent must submit the ~~biennial~~ ~~bi-annual~~ corporate report to the Iowa Secretary of State. This report maintains CCI's status as an active, not-for-profit corporation in the state of Iowa. The Registered Agent is responsible for forwarding the receipt to CCI Secretary that is received once the ~~biennial~~ ~~bi-annual~~ corporate report is successfully filed. The Registered Agent is appointed by the President.

SECTION 6: Elections of Officers

- A. All officers of this Club will be elected for a term of one (1) year. No member will serve more than five (5) consecutive terms as an elected officer on the Board unless no other member wishes to run for office held during the fifth (5th) term. In this event, the

incumbent may remain, with Membership approval, for ~~the oneone~~ (1) additional term in office. Nominations shall be ~~donemade~~ at the August General Membership meeting. ~~An Officer Nomination Committee, consisting of 2 past Presidents, a current Vice-President, and a current Member at Large, will meet in July and will nominate one (1) member for each elected Officer position defined in Section 1 of this Article.~~ The nominations will be submitted to the membership at the August General Membership meeting. Nominations from the floor will ~~then~~ be accepted for each elected Officer defined in Section 1 of this Article and for the Member at Large defined in Section 3 of this Article. A minimum of one (1) nomination from the floor for Member at Large is required at the August General Membership meeting.

A,B. The General Membership will vote to fill a vacancy or resignation of an elected officer. Balloting (including absentee) will be done at the September General Membership meeting by secret ballot. If elected positions have only one candidate running unopposed, they may be voted on by the membership to that position by acclamation.

B,C. Upon request, an absentee ballot will be sent to any eligible voting member of the club who does not expect to be present for the September General Membership meeting. Such request must be made to the Secretary at least fourteen (14) days before the date of the September General Membership meeting. To be counted, the absentee ballot must be returned and in possession of the Secretary one (1) day before the September General Membership meeting. Once a request for an absentee ballot is made, the member may only vote by way of the absentee ballot following the aforementioned provisions, regardless of the member's subsequent ability to attend the September General Membership meeting.

C,D. The Balloting Committee of three (3) ~~non-Boardnon-Board~~ members will be selected by the Secretary from the general membership, none of whom may be running for office. Duties will include: distributing, collecting, and tabulating ballots, and after balloting, the destroying of ballots.

D,E. After the election of the new Board, there will be joint orientation meetings of the new and old Board at the November and December Board meetings. The purpose of these joint meetings is to ensure a smooth transition of duties and responsibilities from the old Board to the new Board.

E,F. The newly elected Board will officially take office during the January Board meeting. The past Governor will continue to coordinate the activities of the Awards Banquet Committee through the date of the banquet under the supervision of the newly elected Governor. At this time, all outgoing Board members will turn over their finalized

ARTICLE 5 - BOARD OF DIRECTORS (BOARD)

SECTION 1:

- A. The Board of Directors (Board) will consist of the elected Officers of the organization, one (1) Member at Large, and the appointed Board members.
- B. One (1) club member will be elected to the position of Member at Large by the members of the club for a term of one (1) year. This election will be held at the September General Membership meeting.

SECTION 2:

Officers of the Board and the Member at Large will have one (1) vote at a Board meeting. Appointed Board members will have no voting privileges at a Board meeting.

SECTION 3:

The Board will appoint the appointed Board members identified in Article 4, Section 2 of these By-Laws. The responsible Board member will also appoint the following standing committees:

- A. Officer Nomination Committee: 2 past Presidents, the current Vice- President, and the current Member at Large (Appointed by the Secretary)
- B. Awards Banquet Committee: Member at Large and two (2) members (Appointed by the Governor)
- C. Treasury Audit Committee: A past Treasurer and two (2) members (Appointed by the Vice-President)
- D. Rules and By-Laws Review Committee: Secretary and two (2) members (Appointed by the Secretary)
- E. Balloting Committee: Three (3) non-Board members (Appointed by the Secretary)
- F. Dues Review Committee: Treasurer, Member at Large, and one (1) full voting non-Board member (Appointed by the Treasurer)
- G. Property Inventory Committee: President and two (2) members (Appointed by the Treasurer)

- H. Advertiser Fee Structure Review Committee: Treasurer and Editor
- I. Points Audit Committee: past Points Director and two (2) members (Appointed by the Governor)
- J. Competition Committee: Competition Director and three (3) members (Appointed by the Competition Director)

SECTION 4:

- K. The Board will appoint all additional committees as needed.
- L. The CCI Board shall have oversight on all technology used by CCI, attempt to control access to member and Club data, and consult with professionals as necessary.

ARTICLE 6 - QUORUM

SECTION 1:

A quorum for a General Membership meeting of this club shall consist of thirteen (13) full voting members (twice the number of elected Board members plus one.) A quorum for a Board meeting of this club shall consist of four (4) of the six (6) elected Board members.

ARTICLE 7 - BY-LAWS OR SUPPLEMENTAL-STANDING RULES CHANGES

SECTION 1:

- A. Any motion to amend the By-Laws and/or Supplemental-Standing Rules of this club must be made at the April General Membership meeting.
- B. Written notification of proposed By-Laws and/or Supplemental-Standing Rules changes shall be published in the May edition of the Sportsmate.
- C. A 2/3 majority vote of the members present and voting at the May General Membership meeting shall be necessary to pass the motion of amendment.

ARTICLE 8 - CONFLICTS

SECTION 1:

All existing By-Laws, or parts thereof, in conflict with these By-Laws, are hereby annulled and repealed. If any provision of these Bylaws or parts thereof are declared invalid, illegal, or incapable of being enforced by any Court of competent jurisdiction, all of the remaining provisions of these Bylaws or parts thereof nevertheless continue in full force and effect, and no provision shall be deemed dependent upon any other provision unless so expressed herein.

Standingard Rules SUPPLEMENTAL RULES

The Standing Rules Supplemental Rules are designed to enhance and expand upon the CCI By-Laws, Standing Rules of the National Council of Corvette Clubs, Inc.(NCCC), and the Competition Sanction Program Rules of the NCCC. These Standing Rules rules supersede all previous CCI Supplemental-Standing_Rules.

GENERAL

1. CCI members should not use or make available the CCI Membership roster for any commercial purpose. Members are prohibited from using or making available to anyone else, for commercial purposes, data that relates to Members and is held in the NCCC database or any other CCI database. Violation of this rule shall result in permanent expulsion from the Club and forfeiture of any dues, fees, or contribution

MEETINGS

1. Board meetings of this club shall be on a dayone day during the first week of the month. This day will be agreed upon by the Board.
2. General Membership meetings of this club shall be held on the third (3rd) Tuesday of each month.

CHARITY

1. The January 1 opening balance of the Charity Fund will equal 10% of the December 31 closing balance of the total Treasury Funds. This is accomplished by an adjustment of Treasury Funds. The adjustment will be 10% of the December 31st balance of the total of the General, Competition, and Charity Funds less the January 1st Charity Fund balance.

The Treasurer is to allocate 10% of the entire funds for the Club as of December 31 to the charitable fund, to be combined with any existing unspent charitable fund monies left over from the previous year, for donation to charitable organizations.



By-Law Review (Continued)

2. The Board will present a recommendation for allocation of the Charity Funds to club members at the February General Membership meeting. The General Membership will vote at that time to determine the final allocation.

SECRETARY

1. The ~~Rules and By-Laws and Standing Rules~~ Review Committee is to meet during March to review and prepare recommended changes to the By-Laws and ~~Supplemental Rules~~ Standing Rules. These changes will be presented to the Board at the April Board meeting. Refer to Article 7 for subsequent By-Laws and ~~Standing Rules~~ Supplemental, ~~Rules change~~ procedures.

TREASURER

1. Treasury Funds will be designated as the following:
 - a. Operating Fund: membership dues, Sportsmate advertising fees, and miscellaneous sources.
 - b. Competition Fund: competition event proceeds and event sponsorship donations.
 - c. Charity Fund: 50/50 drawing, donations, and treasury transfers.
2. The Treasurer will be responsible for issuing ~~checks~~ payments for expense reimbursement requests. These requests must include all receipts.
3. The Treasurer will be responsible for reconciling event registrations to event receipts and deposits.
4. The Treasurer's records will be audited in December by the Treasury Audit Committee.
5. The Treasurer may select the bank of his/her choice with Board approval.
6. An itemized list of CCI properties will be made and kept current by item, location, and ~~the quantity~~ quantity each year by the Property Inventory Committee. This inventory review will be conducted during November and maintained by the Treasurer. The property inventory will include all purchased equipment, as well as gift items, and be posted to the Members Only section of the CCI website by November 30th.
7. An annual donation to be determined by the Club, to the West Region Scholarship Fund will be made in February in the names of Don and Erna Hoskins and in memory of deceased CCI members, as funds permit.

8. Motions from the floor of the General Membership meeting for the expenditure of funds over \$500 must be tabled until the next General Membership meeting. The Board will consider the motion and make a recommendation to the general membership at the next General Membership meeting. At that time, a vote may take place.

9. The Board will be allowed to expend funds up to \$500 without the vote of the general membership. However, all Board expenditures must be presented and approved by the Board before any expenditures, except payments for normal operating expenses such as, but not limited to, items like office supplies or postage.

GOVERNOR

1. The CCI Governor shall be reimbursed for certain expenses for each NCCC Governor's meeting that he/she attends, except for the meeting held at the annual NCCC convention. The Board will establish the level of reimbursement annually but may ~~make~~ adjustments more frequently, if necessary.
2. Sanctioned events in the West Region will be available on the West Region and NCCC websites. CCI events will be made available with event flyers in the Sportsmate.

EDITOR

1. The club newsletter, Sportsmate, will be published electronically and posted to the CCI website and an email notification will be sent to all members when a new issue is posted. Advertisers will be ~~provided~~ provided with a hard copy of the Sportsmate. Club members who request one and selected guests will be ~~provided~~ provided with a hard copy. All hard copies of the Sportsmate will be mailed by the Editor.
2. A list of event sponsors will be published in the Sportsmate and posted on the club website. The list will be updated annually to reflect the active sponsors for that year.

EDITOR AND TREASURER

1. Business advertisements may be placed in the Sportsmate by interested parties in exchange for payment of an annual fee. The Editor and Treasurer will establish and recommend to the Board the fee structure each year in November. The Treasurer will then submit a letter to each existing and potential advertiser by December 1. Ads will run from January through December of each year. Pro-rata adjustment of the fee for any new advertiser who purchases an ad after January will be determined by the Editor and Treasurer. Club members, paid advertisers and event sponsors can each place up to three specific ads free of charge in the Buy & Sell section of any single issue of the Sportsmate.

COMPETITION EVENTS



By-Law Review (Continued)

1. All competition events, whether sanctioned or unsanctioned, will be conducted following the guidelines established by the current edition of the Competition Sanction Program of the NCCC.
2. There are three (3) entities that are primarily responsible for the development and conduct of CCI's competition program. They are:
 - a. Governor
 - b. Competition Director/Committee, and
 - c. Event Chairperson.

Shown below are the responsibilities of each relative to the competition program.

d. Governor

- i. Oversee development and conduct of club competition program.
- ii. With input from Competition Director and Committee, develop a club competition program.
- iii. Request sanctions from Regional Competition Director (RCD) via the NCCC Competition Database; prepare event flyers.
- iv. Ensure insurance requirements are met.
- v. Ensure competition results are complete, accurate, and entered into the NCCC Competition Database following the NCCC Rule Book.
- vi. Coordinate CCI Competition Program with those of other West Region clubs to maximize participation.
- vii. Attend regional/national planning meetings.
- viii. Ensure CCI Competition rules are consistent with NCCC rules.
- ix. Develop and maintain good relations with current and prospective site hosts.

e. Competition Director/Committee

- i. Arrange for the proper storage and maintenance of competition program equipment.
- ii. Arrange for the transportation of competition program equipment to and from events.
- iii. Ensure registration and technical inspection equipment, materials and staff are on hand and functioning properly for each event.
- iv. Ensure timing equipment and power supply are functioning properly. Also, ensure an adequate number of trained, timing equipment operators are present, if applicable.
- v. Ensure award winners are identified and awards are distributed promptly.

- vi. Coordinate special needs/requirements (food, power, water, sanitation, etc.).

f. Event Chairman

- i. Become familiar with the current CCI Supplemental Rules and NCCC Rules pertinent to the event and have the current NCCC Rule Book at the event.
- ii. Inspect the event site, determine the course, and the number of workers needed. (Speed event, rally)
- iii. Lay out the course, and provide a course map. (Speed event)
- iv. Conduct drivers' meetings. (Use meeting outline)
- v. Organize judging teams. (Concours)
- vi. Conduct the event.

COMPETITION EVENT POINTS

1. Only two (2) points will be given to a CCI member driving a vehicle other than a Corvette. The points will be credited to overall points but will compete for guest trophies only. (This requirement will be waived in the case of club rally events. The members may participate in any vehicle meeting safety standards and will receive full participation points.)
2. A CCI member may be a Chairman or Co-Chairman of a CCI sanctioned event only once during the competition year for points. Chairman or Co-Chairman may take the option of points earned by working or take the chance on the points they earn in competition. The option of competition or worker points must be stated by the Chairman of the event BEFORE the start of the event.
3. Points for participation in Competitive Speed Events and Non-Speed Events, whether sanctioned or unsanctioned, will be awarded following the current edition of the NCCC Competition Sanction Program.

CLUB POINTS

1. The competition year for CCI Club points begins December 1 and ends November 30 of the following year.
2. Points will not be credited until annual CCI dues and NCCC dues have been paid.
3. The annual points audit will be completed by the Points Audit Committee by the end of December. Any points recorded after this audit will be added by the Points Director without the benefit of an audit.



By-Law Review (Continued)

4. Members who pay Club dues by October 1 for each year will receive five (5) points to be credited to the following year. Dues must be paid by November 1 each year.
5. Members who attend monthly meetings and register will receive five (5) points for each meeting attended. The business portion of the monthly meeting must be attended and no member may sign for another on the register to qualify for the meeting points.
6. Members will receive four (4) points for any CCI Club event that is held while they are out of town attending an NCCC Governors' meeting.
7. Board members will receive five (5) points for attending any club board meeting.
8. President will receive five (5) points for the planning for all monthly meetings.
9. Secretary will receive five (5) points for completion and presentation of all of the minutes for the month (including Board and Regular Meeting minutes as one).
10. Treasurer will receive five (5) points for completion and presentation of Club Financial reports such as a Treasurer's Report.
11. Editor will receive five (5) points for any monthly publication.
12. Planner for any club social or competition event will receive five (5) points for the planning of such event.
13. Governor will receive five (5) points for attendance at each Governor's meeting.
14. Members who recruit new members into CCI will receive two (2) points for each new member. The member receiving the points must be indicated on the CCI application. The points will be recorded in the Recruiting category.
15. No Club points will be awarded during the NCCC Convention.
16. Social events can be strictly social, community service-oriented (including charities), or a combination of the two. In the case of a combined social and community service event, party points and community service points will be awarded, however, members must attend both segments of the event to be awarded both sets of points. The notice/flyer must be communicated to membership (7) days before the event and indicate four (4) party points and/or four (4) community service points will be awarded.

17. If NCCC rejects or disallows individual points for an event, the club should disallow club points for the event.

17-18. It is the responsibility of anyone attending the Governor's meetings to supply suitable documentation to the Points Director to receive points for those events. It is also the responsibility of the officers submitting regular monthly reports to provide the Points Director with suitable documentation.

AWARDS AND RECOGNITION

1. The CCI Board will approve the year-end competition award and recognition winners as presented by the Points Audit Committee.
2. The competition awards to be presented are:
 - a. Overall Participant Award: Will be awarded for the highest total points earned for the Don Hoskins award and the total points earned at all NCCC sanctioned events.

1st LadiesWoman
 - b. Don Hoskins Award: Will be awarded for the highest total points earned as follows: dues paid, recruiting, all items referenced under Club Points, items 7 through 12, Board meetings, general meetings, CCI social events, CCI community service events, event worker for any NCCC sanctioned events, and NCCC National Convention points.

Overall WomanLadies
 - c. Funkhana, Rally, and Concours Award: Most NCCC points accumulated in a minimum of 3 funkhanas, rally's, and/or concours' in a competition year.

 - d. Speed Event Award: Most NCCC points accumulated in a minimum of any combination of 7 low speed, high speed, and/or drag events in a competition year.

- e. Rookie of the Year Award: To qualify as a “rookie” in CCI, an individual may not have participated in more than 7 NCCC events in any previous year as a member. These trophies will be awarded to the male and female CCI members with the most NCCC points accumulated in at least 10 sanctioned events in the current competition year. A member is only eligible to receive this award once.

3. The recognitions to be presented are:

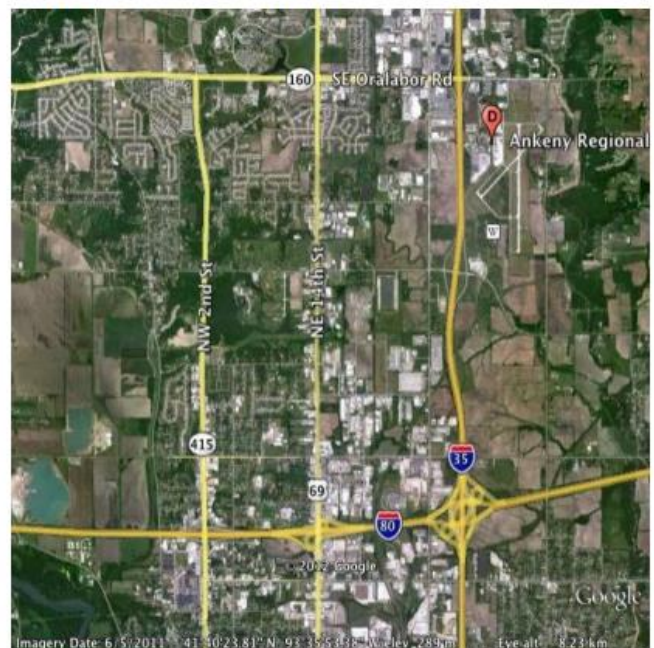
