



## Governor's Message...

Hi, everyone! We are moving forward at full speed with our Ankeny low-speed autocross, scheduled for May 29-31 at the Ankeny Airport. Planning for the Chariton event is also on-

schedule for June 26-27. I hope to see a lot of you at these events – either to participate, to work, or to just check it out as a spectator.

Since my last Governor's Report, I attended the Governor's Meeting in St. Louis and I have a few things to report, as follows:

- Several regions are trying out Time Trials, where you run timed laps but there are other cars on the track at the same time. From what I heard, they've had good luck so far and participants seem to like them.
- There is no drag index for the new C8 Corvettes. RCDs will collect data this year and decide on indexes for next year.
- In the RCD meeting, they discussed allowing smaller steering wheels & quick release for all cars. For safety reasons, this idea was voted down.
- There was discussion about pandemics and how to handle it if things get bad, again, or how to be prepared if we should have another one. RCDs are working on this as it affects competition events.
- C7 Grand Sports will now race in MM Class (Same subgroup as M & N).
- There have been some issues with NCCC membership cards. The printing is misaligned. Contact Nan Brittain or me if yours is not right.
- We were, again, told to get waivers signed for all events, including meetings. I'm checking to determine if our method of obtaining signatures at meetings is appropriate.

NCCC has received 14 scholarship applications this year. They will award 7 scholarships. This is different than the West Region scholarships that are available. **I would encourage any CCI member, their child or grandchild who plan to attend an accredited college or a vocational/technical school to apply for one of the WR Scholarships. To do so, go to the West Region website at [www.westregionnccc.com](http://www.westregionnccc.com) and click on Scholarships. Deadline for mailing your completed application in is August 1.**

As I wrote this message and thought about the material I was writing, it occurred to me that many of our members may not understand how our club functions and what the relationship with

NCCC is. Let me explain... The National Council of Corvette Clubs, Inc. (NCCC) was founded as an all-volunteer, non-profit organization in 1959 by a small group of Corvette owners/enthusiasts. The purpose of NCCC was (and still is) to promote interest in Corvette ownership and operation, to publish information on the use and operation of the Corvette and to establish an organized effort to encourage others to participate in the enjoyment connected with the use and ownership of the Corvette ~ America's Sports Car! CCI member Denny Luther sits on the NCCC Executive Board in the position of Parliamentarian. There are 16 regions across the United States with 234 NCCC clubs. Prior to the April/May Governors' Meeting, there were 16,790 NCCC members. Corvette Club of Iowa (CCI) is one of those 234 clubs. CCI was founded in 1962 and became part of the West Region of NCCC. CCI also has representation on the Regional Board with Nan Brittain, Regional Membership Director (RMD); Jay Hommer, Treasurer; and Linda Hommer, Secretary.

As club governor, I am the liaison between the NCCC/West Region and CCI. As such, I attend Governors' Meetings, report the business of those

sessions to club members and am responsible for issuing NCCC membership materials. As a CCI member, you are part of a group of more than 16,000 like-minded people from around the country who are resources when you need information, participants at competition events and friends in new places when you want to socialize. There are also a number of NCCC members, nation-wide, who are part of a program called Family Helping Family. The idea of this program is to provide someone to reach out to for help if you're traveling and your car breaks down or you have trouble away from home. I hope that I have given you an idea of what you've become part of by joining CCI/NCCC. The more I learn about how the club functions and how it fits into the bigger picture (NCCC), the more I enjoy it.



# **Recommended 2021 Changes/Additions to CCI BY-LAWS**

## **ARTICLE 2 MEMBERSHIP**

### *SECTION 2 – Definition:*

- A. Individual Member-A member of CCI (~~a not for profit Iowa corporation~~).
- 

## **ARTICLE 3 DUES**

*SECTION 1* – Initial dues of the CCI ~~“Corvette Club of Iowa, Inc.”~~ shall be accepted anytime during the year.

*SECTION 2* – Those wishing to join after the August General Membership meeting will pay current year dues which will cover ~~be for~~ the remainder of that year plus and the entire following year.

---

## **ARTICLE 4 OFFICERS, APPOINTED BOARD MEMBERS, THEIR DUTIES AND TERM OF OFFICE**

*SECTION 4* – One appointed Registered ~~Corporate~~ Agent.

### *SECTION 5 – Duties*

- A. The duties of the President are to preside at meetings and to act as official officer for any club meetings. The President has the responsibility of conducting the meetings according to “Roberts Rules of Order”. The President has the right to call any special meetings considered necessary. Proper notice of special meetings shall be given at least three (3) days in advance. The President is responsible for supervising and coordinating the activities of all elected Board members. The President is to insure elected officers fulfill their obligations and appoint committee chairpersons and members promptly. The President should verify whom the Registered Agent is annually. The name will be published on the website and in the Sportsmate.
- L. The duty of the Registered ~~Corporate~~ Agent is to submit the bi-annual corporate report to the Iowa Secretary of State. This report maintains CCI’s status as an active not for profit corporation in the state of Iowa. The Registered ~~Corporate~~ Agent is responsible for forwarding the receipt to CCI Secretary that is received once the bi-annual corporate report is successfully filed. The Registered ~~Corporate~~ Agent is appointed by the President ~~and is currently Tim Ford~~.

### *SECTION 6 – Elections of Officers*

- B. The General Membership will vote to fill a vacancy or resignation of an elected officer. Balloting (including absentee) will be done at the September General Membership meeting by secret ballot. If elected positions have only one candidate running unopposed, they may be voted on by the membership to that position by acclamation.

## MEETINGS

1. Board meetings of this club shall be on a day during the first full week of the month. This day will be agreed upon by the Board. ~~normally be held on the first (1st) Tuesday of each month unless a conflict exists.~~
2. General Membership meetings of this club shall be held on the (3rd) Tuesday of each month.

---

## TREASURER

7. An annual donation of at least \$750 to the West Region Scholarship Fund will be made in February in the names of Don and Erna Hoskins and in memory of deceased CCI members, as funds permit.

---

## EDITOR AND TREASURER

1. Business advertisements may be placed in the Sportsmate by interested parties in exchange for payment of an annual fee. The Editor and Treasurer will establish and recommend to the Board ~~review~~ the fee structure each year in the month of November. The Treasurer will then submit an invoice to each existing advertiser by December 1. Ads will run from January through December of each year. Pro rata adjustment of the fee for any new advertiser who purchases an ad after January will be determined by the Editor and Treasurer. ~~Ads will be available in one of the following: 1) business card up to 1/4 page at \$60, 2) greater than 1/4 page up to 1/2 page at \$120, 3) full page at \$180.~~ Club members, paid advertisers and event sponsors can each place up to three specific ads free of charge in the Buy & Sell section of any single issue of the Sportsmate.

## CLUB POINTS

9. Social events can be strictly social in nature, community service oriented (including charities) or a combination of the two.
