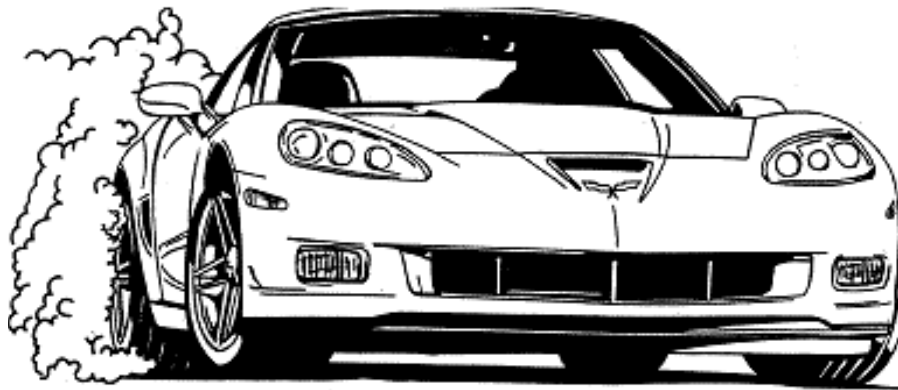

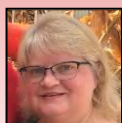

## Officer Reports

### From the President...

Greetings Corvette Club of Iowa Family,

The warmer weather has finally led to the return of car shows. Just recently I was at the DMACC Car Show that is a highlight event for their Collision Repair Training Program. It was a fantastic turn-out with cars of all types. There were even some restored tractors. Good food (thanks to Smokey D's), great cars, some live music (my opinion of the quality of the music is not important) and some great conversations. I had a chance to talk with my friend and member Paul Wyman. I always enjoy my conversations with Paul and look forward to those opportunities. The topic of part of the conversation that struck me the most was the discussion of our first cars. I won't share Paul's story because it is such a good story and you need him to tell you. As I drove home from the event, I was still thinking about my first car – a 1986 Oldsmobile Calais 2 door with the Tech 4 motor in it. It was a great car. I even did my usual routine and took this old car with high miles and brought it back to life. It wasn't a classic or even a really nice car in any standard, but I cleaned, polished and made that car look like a show car. There was one little problem, it had LOTS of rock chips in the hood. I took it upon myself to touch up the chips and make it look like new again. Problem was I had no idea what I was doing (I was 16 after all). I remember being smart enough to ask someone at AutoZone what I should do. However, I was not smart enough to realize this was too big of a job for me. The employee at AutoZone recommended that I use spray car paint to get a more even appearance and finish. I proceeded to lightly sand the hood, tape it off, and began using one of the 3 cans of spray automotive paint I bought to paint it. The results were horrific. No gloss, rough appearance, runs, drips, pitting, just a bad job done. My father was furious that I ruined this car. At the same time he laughed a little inside at my mistake. He knew it was a learning experience and not out of the realm of something he would have done at my age. He also knew I would have to deal with the embarrassment as I drove the car to school.

Mistakes are a part of life. They are a part of learning, growing and making ourselves better. Sadly the way society teaches is that mistakes mean you are a failure. Mistakes are things to be avoided and if you make one you are lesser of a person. As I reflect on that first car and the cars I had after that, I can see continued mistakes. Albeit not the same mistake again and again. When my father taught me how to take an engine apart completely and rebuild it, I can remember lots of mistakes but I learned from each and every one of them. I still make mistakes to this day (just don't tell my wife), but each one is a lesson to grow from.

We are turning 60 years old as a club. There have been mistakes made. That doesn't mean the club or members are failures, but simply that they were learning opportunities. As we reflect on all this club has done over 60 years, I challenge you to reflect a little. What was your first car? What lessons did you learn from it? What was your favorite car you owned? What would you have done differently? Anniversaries as a great chance to review those lessons learned that we may have forgotten. This reflection has helped me even today. I bought my son Blake a C5 Corvette PowerWheel (they are extremely hard to find). My plan is to paint it to match my Lemans Blue Corvette. I simply haven't had time to get to it lately. Thanks to my conversation with Paul and the reminder of the mistake I made when I was 16 with my Calais, I will be painting it differently. I won't make the same mistake twice. I encourage you to reflect on the joys as well as the lessons learned in your own life and also in this club. Your Board is working hard to improve this club, keep it growing and thriving, and keeping us from making mistakes. Even as those mistakes might still happen, we will learn, grow and become better.

## Governor's Message...

As your club governor, I'd like to briefly address some upcoming Corvette Club of Iowa events, including the 60<sup>th</sup> Anniversary celebration, the Memorial Day Weekend Autocross at the Ankeny Airport, and the continued need for event workers.

The CCI 60<sup>th</sup> Anniversary celebration will take place Tuesday, May 17, 2022 at Camp Dodge Pavilion in Johnston, Iowa. There will be a cruise-in type of event, beginning at 2PM, and the Gold Star Museum will be open from 2-4PM. We're planning to take a group photo of CCI member Corvettes at 5PM, sharp. Mike Golightly and his committee members have put in a great deal of work to make this celebration a memorable event, and it would be great to see a large turnout. The event will feature two special guests, including **Dale Samuelson, NCCC President**, and **Kai Spande, Plant Director at the Corvette Assembly Plant**. You are encouraged to pre-register for the event, so the proper number of meals can be ordered. **To attend, please go to the club website at [www.corvetteclubofiowa.com](http://www.corvetteclubofiowa.com) and click on the ACTIVITIES tab, then SOCIAL EVENTS.** Then, just click on REGISTER HERE and it takes you to the registration form which is simple to complete. Meals are priced at just \$15 per member. This is the same night as our general meetings are scheduled on. So, if you're not registered and you're waiting for a personal invitation, please consider this to be it. I really hope to see you there to help celebrate our club!

Our first low-speed autocross of the year will be May 28-30. It's a 21-event weekend that's always fun. If you want to register to compete, please paste the following URL link into your Internet browser:

<https://www.corvettesnccc.org/NCCCOOnlineRegistration/Programs/Registration.php?eventId=305>.

That will automatically take you to the registration page. Skip the car number at the top of the page. For some reason the database fills that in with the next sequential number. We can change the number later, if you have paid for a permanent West Region number. Start your registration by filling in your NCCC number in the appropriate box. If you don't know your

number, it's on your NCCC membership card. The other fields will self-populate down to information about your car. Enter that information, including the class you run in. If you don't know that, you can look it up using the NCCC Competition Rulebook that can be found on the NCCC website at [www.corvettesnccc.org](http://www.corvettesnccc.org). You will then have to check off the boxes corresponding to the events you want to participate in. So, if you want to run all 21 events, you'll have to click all 21 boxes. When you hit enter, you are registered. **To get the early registration price, you must mail your check to Treasurer Laurie McCracken by not later than May 20, 2022.** The Iowa Aviation Museum will provide lunches Saturday-Monday, and they will offer dinner Saturday night. (It's always great food!) Some awesome T-shirts commemorating this event will be available for sale at only \$20 each.

Obviously, we still need volunteer workers for this event and others. We have taken steps to try and ensure a safe environment for competitors and workers at our speed events this year. We won't be asking anyone with mobility issues to work corners. However, we will still have many other things to do that we need help with. Even if you're not a racer, please come out to volunteer your help or just bring your lawn chair to enjoy some time watching the competition and hanging out with other Corvette people.

CCI's 2<sup>nd</sup> 2022 autocross event is scheduled for September 24-25, 2022 at the Ankeny Airport. It will be a normal two-day weekend with 14 events. The weather should be perfect for enjoying a fall day outdoors. If racing doesn't interest you, we are also planning a rallye that we're calling the Lawman's Pokey Run for September 18, 2022. It's simply a poker run with a law enforcement/jail theme. I think it will be a fun time.

I hope we can count on your support for these events that your fellow club members have spent many hours planning and working. I look forward to seeing you soon.

## Meeting Minutes

### Board Meeting, April 7, 2022

The Board meeting of Corvette Club of Iowa was called to order @ 6:18PM, April 7, 2022 at The Whiskey House in Ankeny by President Jeff Jackson. Secretary Dave McChesney was not present and Dave Howard volunteered to keep minutes. President Jackson first urged the Board to have a strong presence at the club's 60<sup>th</sup> Anniversary Party. He also said that he wouldn't be able to attend the April general meeting and that Pat couldn't be with us this evening.

Jeff asked if everyone had taken the opportunity to review the minutes from March 3<sup>rd</sup> and solicited comments or corrections. None were brought up and Laurie McCracken made the motion to approve the minutes as presented. Jeff seconded and the motion passed unanimously. Laurie submitted her Treasurer's report for March with details of receipts and disbursements. Carrol McCracken made a motion to bring the report to the membership with Gary Foster offering the second. The motion passed unanimously.

## ***SPECIAL CORVETTES (Part 2)***

As I noted in last month's *SPECIAL CORVETTES (Part 1)*, I became a Corvette fan at about 5 years of age when my cousin got one. That car left a lasting impression on me because it was so different than anything I'd ever seen. It was stylish, loud and brash, nothing like the conservative vehicles my father and grandfather used. This car started my life-long love affair with the Corvette and since then, I have taken every opportunity to refresh my relationship with this wonderful car. I have experienced the finest examples of the evolution of the Corvette at venues such as Bloomington Gold and touring the GM Heritage Collection in Detroit, both of which I spoke about in last month's piece. However, without question, my security work at the Barrett-Jackson auctions has afforded me the best chance to literally get involved with some of the rarest of Corvette history.

## **BARRETT-JACKSON**

Following my retirement (the first retirement, on December 30, 2006), I wanted to go see the famous Barrett-Jackson auction that I had seen on TV. My buddy, Jerry, was excited to go along. He couldn't remember the dates, so he went to the Barrett-Jackson website. In addition to finding the dates of the Scottsdale event, he also noticed that they were hiring security staff. He sent in his resume and insisted that I do the same. I had worked my way up the ladder in the sheriff's office before becoming chief deputy. After retirement, I wasn't crazy about the idea of starting at the bottom, again, and working at some lonely gate in a parking lot where I wouldn't expect I'd see any of the cars or catch any of the excitement of the auction. He pushed and pushed me to send in my resume, so after he mentioned that it might pay for some of our trip, I relented and applied. It didn't take too long before they called to offer us jobs. When I pressed them as to where we would be working, they told us we would be right up on the block where the cars were auctioned. I was skeptical and only accepted the job with the understanding that I would try it, but if I didn't like it, I wouldn't stay. Needless to say, I loved it! Jerry stayed for several years, and I really enjoyed working with him and many others who would become my friends. Well, I soon became the director of security for Barrett-Jackson and traveled to all of their auctions around the country. In fact, I would still be there if I hadn't gotten too old for the long hours and miles of walking every day. I didn't feel that I could do the job justice any longer. I got to meet a lot of wonderful people and saw lots of amazing cars. Some of them are as follows:

### **Purple People Eater**

The Purple People Eater MKIII Corvette (Lot #1389 at Barrett-Jackson 2016), was raced on behalf of the Nickey Chevrolet dealership in Chicago by driver Jim Jeffords. Together the car and driver won the Sports Car Club of America National B-Production championship during the 1959 season.



In 2002, Jeffords was inducted into the Corvette Hall of Fame at the National Corvette Museum in recognition for "his exciting racing mark in legendary race cars and automobiles," including the "Purple People Eater" as well as Chevrolet-powered specials like Jerry Earl's SR-2, the Scarab and the Maserati Birdcage.

### **Barrett-Jackson GM Heritage Prototypes & Concept Cars**

In 2008, GM was in dire straits, financially. GM was taking on a government bailout and was doing whatever it needed in order to survive – and that included selling off its historical concept cars.

So, in early 2009, General Motors took hundreds of concept cars, preproduction vehicles, race cars, SEMA show cars, test mules and all sorts of other things to the Barrett-Jackson auction in Arizona for a huge sell-off. I was privileged to be working security on the auction block at that time, so I got to view and touch all these cars that included the following, among others:

- 1989 ZR-1 Corvette coupe. This car saw duty in media/press events.
- 1989 ZR-2 Corvette coupe, "Big Doggie". This was an experimental car used to determine how to convert a small block car to a big block car with a 454 cubic inch engine.
- 1989 ZR-1 Corvette coupe "Snake Skinner". This was 1 of 83 production ZR-1s built in Bowling Green. It was made with lightweight parts and a 475-horsepower engine, making it a GM performance legend.

- 1989 ZR-1 (DR-1) Corvette convertible. This was a prototype that never made it to production.
- 1989 ZR-1 Corvette “Snake Skinner II”. This car was made to be identical to Snake Skinner I, but without all the same engine upgrades.
- 1990 “Active” ZR-1 coupe. This car was equipped with active suspension and GTP Corvette race car technology.
- 2000 C5 Z06 prototype



I feel very fortunate to have so many memories of wonderful cars that I’ve owned or those special ones I’m grateful to have just seen. I still enjoy any opportunity I get to drive or view artistic and memorable cars and to share what I know about them with my children and grandchildren. Again, I hope that sharing my experiences has stimulated some memories in you, too. Happy motoring and... *Save the Wave!*

# BY-LAWS

## CORVETTE CLUB OF IOWA, INC.



### ARTICLE 1 – NAME-PURPOSE-LOGO

**SECTION 1:** The name of this Club shall be Corvette Club of Iowa, Incorporated.

**SECTION 2:** The purpose of this "Club" shall be the furtherance of interest in Corvettes and related activities.

**SECTION 3:** The Club's logo shall be a design of a "Corvette" steering wheel on which shall be inscribed the words "Corvette Club of Iowa," and CCI as shown below.

**SECTION 4:** Corvette Club of Iowa colors shall be red, black, cray, and white.

### ARTICLE 2 MEMBERSHIP

#### **SECTION 1 - Qualifications:**

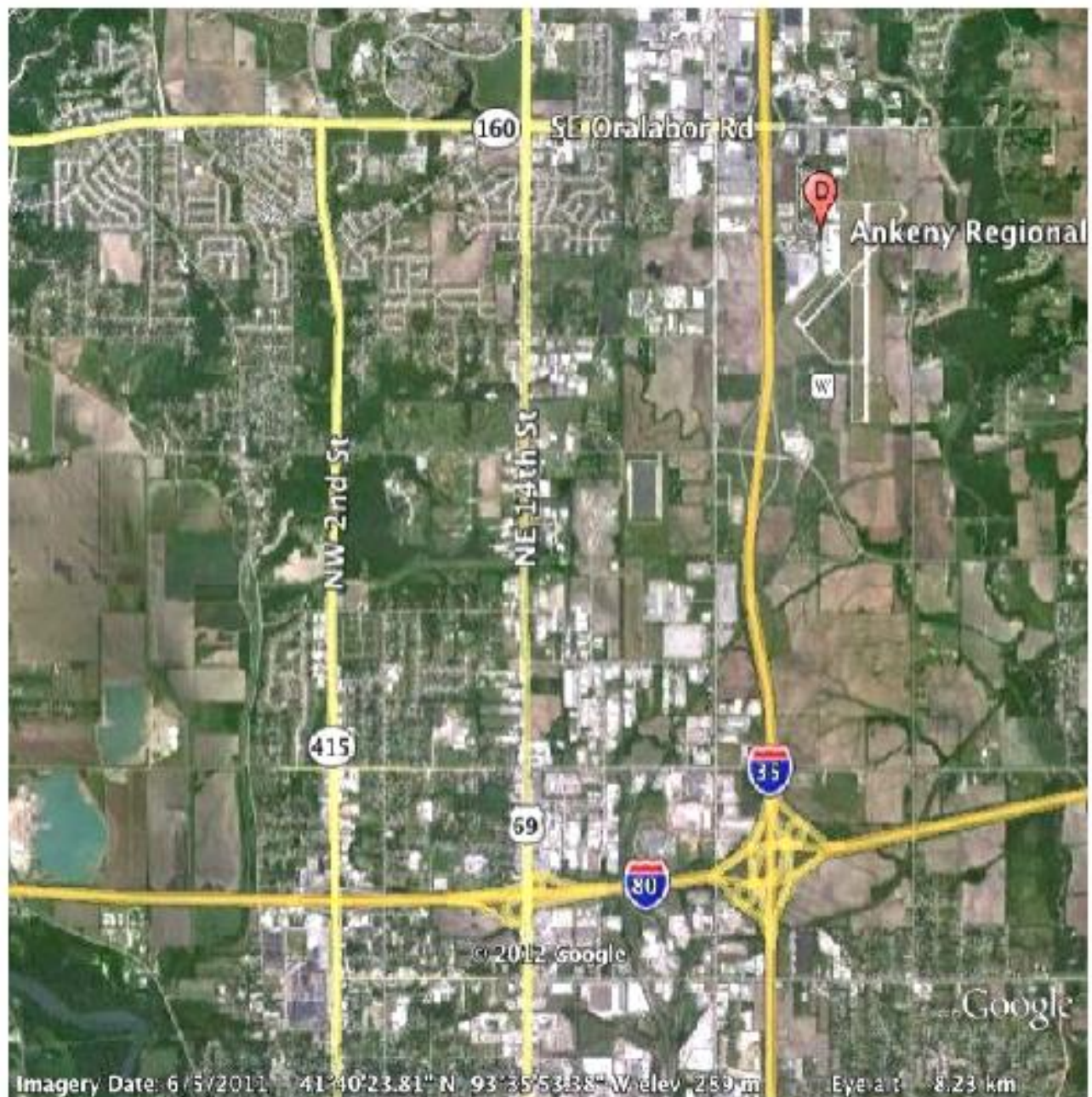
