

I understand that there were no applications for the West Region scholarships this year. I think that is a real shame. The deadline is always August 1st and all the pertinent information is available on the WR website.

Unfortunately, due to circumstances beyond my control, we were unable to have the Competition Program Review Committee meeting last month that we had been planning.
