## Meeting Minutes

## General Meeting, September 21, 2021

CCI's September general meeting was held at Jethro's in Ankeny. The meeting was called to order @ 7:02PM by President Nichole DiMaio. Members at this meeting: see sign in sheet. There were no new members or guests present and Nichole moved on to the reports from club officers.

#### **Officer Reports**

President's Report: Nichole had nothing additional to report. Secretary's Report: Jeff Jackson sought comments on the minutes from the August meeting and hearing none, Ken Wilson made a motion to accept the minutes as published. Jim Lucas seconded and the motion carried unanimously. Treasurer's Report: Laurie McCracken gave the financial report for August, 2021. A motion to receive and file her report was made by Paul Wyman and seconded by Jim Lucas. The motion carried unanimously.

Vice-President/Social Director's Report: Carrol McCracken is looking at doing a fall color run to Northeast Iowa, October 30<sup>th</sup> & 31<sup>st</sup>. The plan is to overnight in Guttenberg, Iowa on the Mississippi. Governor's Report: Gary Foster gave details from the Regional meeting on Friday, September 10<sup>th</sup> – there were three by-law changes. December 15<sup>th</sup> is membership dues deadline. 2<sup>nd</sup> change is a list of new duties for Vice President of Membership. NCCC wants to remove written

ballots and have balloting on line. Developing a plan for what happens if clubs pull out of NCCC. Also, discussion on long pants in groups 1 and 1S and also group 2. No applicants for West Region Scholarships. Might be time to increase the amount or number of scholarships. This will be discussed at another time. Discussions were had about increasing participation. New officers were announced for the Region. 17,892 NCCC members as shared at National Governors meeting. Discussed some rule changes through RDC Group. First change is reducing events per day from 7 to 5 events. Will be voted on next meeting. 2017 and newer Grand Sports will be their own class, MM. Snell helmet is good if the manufactured date is less than 10 years old. Discussion on the time trial structure. 2022 Convention will be in Atlantic City. No current National Scholarships will 2023 proposal. increase to \$2,000 each, only 8 a year. National Officer Candidates were shared. Competition Director's Report: Luke Stilley acknowledged the Trailer Girls who have decided to retire from running the timing trailer at autocross events. We are seeking others that would like to be trained and help run the trailer/timing.

Member at Large Report: Wayne Weidmann was not present and there was no report. Editor's Report: Dave Howard had no report. Points Director's Report: Mike Golightly said points have mainly been for the recent cruises. Membership Director's Report: Mike has seen an increase in membership every month except this last month. Many car shows coming up and those are great chances to recruit new members. Social Media Director's Report: Pat Whalen said the last email was sent with a blind distribution so check your junk mail if you did not receive it.

Old Business: Officer nominees from the Nominating Committee are: Jeff Jackson. President; Carrol McCracken, Vice President; Dave McChesney, Secretary; Laurie McCracken, Treasurer and Gary Foster, Governor. Nichole opened the floor for nominations. Gary nominated Wayne Weidmann for Member at Large. Denny Luther then moved to cease nominations, Jim Lucas seconded and the motion passed unanimously. Since all candidates are unopposed, Nichole moved to acclaim the candidates as the Officers for 2022, Judi Nikolish seconded and the motion passed unanimously. New Business: discussion of CCI's 60th anniversary and moving the club photo to Spring. Jim Lucas notified us of a car show put on by Mac Brothers on October 9th at Saylorville. Paul Wyman reminded us that TP Roundup for Veterans will be next month at the general meeting. Ozark International Raceway is under construction and some events could be scheduled for next year. Per Jay Hommer, Larry Steffen's wife passed away. Jean Mark lost her sister Jill in a car accident. Buy and Sell: none.

A motion for adjournment by Ken Wilson was seconded by Wayne Nikolish. The meeting adjourned @ 7:42PM.

#### **Officer Reports**

President's Report: Nichole DiMaio said the new 2022 Board member, Dave McChesney, will be invited to the November and December Board meetings to transition and familiarize him with the process. The Board member email list will be updated to include him. Nichole pointed out that the Membership Renewal form has a line that

needs removed for the Lifetime Member. Per the By-Laws must be 10 consecutive years. Secretary's Report: Nichole filled in for Jeff Jackson and asked for a motion to approve the September Board meeting minutes. #### **Events**

Here's a wrap-up of recently held events along with a description of events on the horizon:

**From Jethro's to Points Northeast.** CCI members were out in force in their Corvettes recently for what could prove to be the last few times this season! Once again many of them drove their Vettes to the October general meeting at Jethro's in Ankeny. Then at the end of the month, a good-sized contingent got together for a Fall Color Run to northeast Iowa (more on that immediately below). Enjoy all the photos on the succeeding pages!

**2021 Fall Color Run.** Carrol and Laurie McCracken organized the weekend-long Fall Color Run that took place at the end of October. Here is Carrol's narrative for the weekend:

On October 30<sup>th</sup> & 31<sup>st</sup>, Laurie and I had the pleasure of leading 11 Corvettes (including ours) and all of the pilots and passengers up to our home territory in northeast Iowa. It all started with gathering near Cambridge, Iowa, on a crisp, windy and chilly Saturday morning. Much too early for me!

Besides the cool conditions, one of our members had a car problem, but we were glad they were able to join our group a little later in Tama. Then a little later on the trip, jumper cables were necessary to get a car started in Palo. Thankfully, that car was able to make the trip over the rest of the weekend without assistance. I think a few of us started to wonder if there was some black cloud that would be following us on the trip.

We picked up another Corvette and Camaro while in Palo, and learned the young man driving the Camaro had received his driver's license 5 days ago. What a way to spend part of your first week driving in a group of great cars! We stopped at Chad's Pizza in Dyersville for a great pizza and lunch buffet and then went to the Field of Dreams. After the Field of Dreams, we were off to an ice cream social at my sister's house where it seemed like everyone had a nice break from their cars for socializing. It helped that my sister and brotherin-law (Yvonne and Jim Brown) are Corvette owners. We appreciated them opening their home to a large group of visitors. When everyone was done with their treats and some chatting, we headed down the hill to stop at a roadside view and then to our hotel for the night, The Landing, in Guttenberg. The Landing is a nice hotel that started as a warehouse in 1858, then had other uses over the years. In 1910 it became the Empire Pearl Button Company where clammers would deliver clam shells which would be cut and drilled for buttons until plastic buttons, over-harvesting and regulation of clamming drove these factories out of business. While the demand was lower, I still remember seeing clamming boats while growing up in Marquette.

Sunday morning started similar to Saturday when misfortune struck again with someone doing a hit and run by backing into and damaging our car and leaving without contacting anyone. It put a damper on the trip a little, but we continued to go to one of the best views we can see of the Mississippi River valley at Pikes Peak State Park. From there, we drove to Marquette, Iowa, and stopped at the Casino Queen so pictures could be taken with Pinky. Yes, a life-size pink elephant that stood beside the Pink Elephant Supper Club since 1963 or 1964. We continued with a short trip to Prairie du Chien, Wisconsin, which included a drive around St. Feriole Island and a stop outside of a historic landmark, the Villa Louis mansion built by Hercules Dousman, an early fur trader and real estate investor who started his business there in 1826 and was believed to be the first millionaire in Wisconsin. Now back to Iowa where I think everyone enjoyed our stop at the award-winning Eagles Landing Winery in Marquette. After a few dozen bottles of wine went out to the cars, we drove some winding roads, with a great roadside stop where you could view the Mississippi River Valley for miles, and had our next stop at Breitbach's Country Dining restaurant in Balltown, Iowa. It is the oldest continuously operating bar and restaurant in Iowa, open since August 23, 1852. Back in the cars for the drive home, trying to take as many windy roads as possible. This even forced one car to pull over for an ill passenger (in all honesty, I was the driver... sorry Laurie!). Along the way back to central Iowa, we had one final stop for a photo at Iowa's largest skillet in Brandon. Everyone split off at Marshalltown toward their homes.

Thank you for being a great group. I have to mention that we greatly appreciate Brian Sult's help. He brought up the rear of our group and kept us informed both days that everyone made our turns and that our group was together, and came to the rescue with some supplies for the carsick passenger mentioned earlier. He has also volunteered to help with planning and participating in similar events next year. Thank you, Brian!

It was a fun trip even with the troubles. Laurie and I hope we can do more of this when the weather allows this next spring.

Luke Stilley's "G10" Concept Build Q: Nichole DiMaio A: Luke Stilley

**Q:** What are the vehicles you are starting with?

A: The chassis is a 2009 Pontiac G8 GT that was my parts car for my track car. It had a damaged roof and was missing most of the body parts, so it was a perfect candidate for this idea. The C10 is a 1972 GMC <sup>1</sup>/<sub>2</sub> ton SWB. The cab needed rockers and the floor replaced anyway so if this idea failed it would be no harm, no foul.



**Q:** What is the general idea of the build?

A: The general idea of this build was to make something unique and updated while still retaining a stock looking vehicle. I wanted to do something with all the left-over parts and pieces I had around. This also allows me to run a truck in the drift sanctions I am in, as they do not allow body on frame vehicles to compete.



**Q:** What can you tell me about the measurements of the truck and car?

A: Initially I was only planning to utilize the newer suspension from the G8, but looking at the two side by side I realized how similar in size they were. After measuring the wheelbase, firewall height and width and front axle centerline to firewall, I realized they were nearly identical in every measurement.



**Q:** How many G8s do you have? (No value added, it's just too funny not to ask!)

**A:** I currently own 3 G8's if you count the chassis under the truck. I have owned a total of 6 of these cars. They are great!

#### **Q:** Where did you get the idea?

A: I've always admired the fantastic chassis that underpins the G8, as it's the same chassis that is under the 5<sup>th</sup> gen Camaro and multiple GM cars in Australia. I always wanted to do something more with one of these cars. The C10 frame left me with lots to be desired in the rigidity department. There is a lot of flex and twisting movement in these frames that would not work for what I wanted to do. This gave me the idea to merge the two together.

#### **Q:** What do you plan to do with it?

**A:** My plans are to drive the truck as much as possible and use it as a test bed for different suspension components and drivetrains. Any suspension parts from a 5<sup>th</sup> gen Camaro fit this chassis, so there are a lot of parts that can be mixed and matched.

**Q:** If you drift it, are you worried about the side panels being destroyed? How will you replace them? Will you avoid tandem for less collision?

A: This truck will have the "patina" look, so the body will be all original and have its original paint, dents and dings, therefore some battle scars and wounds will add to the look of the truck. If the truck suffers major damage, I will try to find used parts to replace them. Tandems are the best part of drifting, so me saying no to them would be incredibly hard.

**Q:** Can you tell me more about the interchangeable suspension parts?

A: Like stated earlier, the G8 uses the same chassis as the 5<sup>th</sup> gen Camaros, Cadillac CTS and multiple other cars in the GM arsenal. Multiple parts are interchangeable, especially with the G8 and Camaro. Brakes, suspension arms, differentials, engines, transmissions and multiple other items all can be swapped from car to car. My drift G8 and this C10 will be set up nearly identical suspension-wise, so parts swapping will be easy if I ever break something or need a spare part for a race event.

**Q:** What will you use for the engine and drive train?

**A:** The initial engine for this project will be a 5.3 V8 from a 2004 GMC Sierra and a TR6060 6-speed transmission from a 2012 Camaro SS. This engine will be either be supercharged or turbocharged to around 600 horsepower.

**Q:** What have you done on the build so far?

A: So far, the G8 chassis has been cut down to rough size, and the floor and firewall have been cut out to slide over the chassis. The body is sitting in place over the car and ready to start fabricating mounting brackets. The Custom BC racing coilovers have been installed to measure final ride height and the engine and transmission are in to start finalizing the engine bay. Next will be fitting the steering column and interior parts. **Q:** What do you have in mind for paint?

**A:** The paint on this will be all original, rustic looking, this way I will not have to worry about scratches, dents and dings.

**Q:** What do you have in mind for the interior?

**A:** The interior will be a mix of G8, newer GM truck and original '72 C10 parts. G8 seats will bolt right in, as the floorboard is from the G8, along with the center console. The dashboard will be the factory C10 dash and the steering column is from the newer GM truck.

**Q:** Functional truck bed? Cage Bars?

**A:** The truck bed will be raised to cover the factory G8 rear floor pan but will be the original factory wood and factory appearing. It will have a full roll cage to be legal for the drift events I run.

Well, thank you Luke for filling us in on your concept, and we can't wait to see how it turns out!
