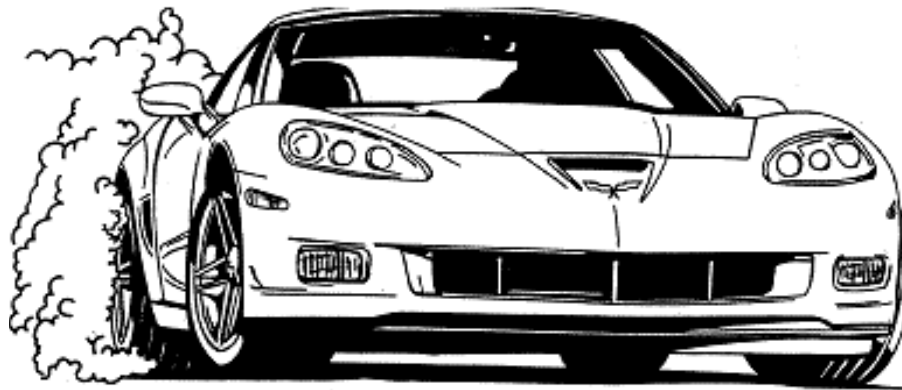

Meeting Minutes

Board Meeting, December 1, 2020

The CCI Board held the December meeting virtually via Zoom. President Dave Howard called the meeting to order @ 6:32PM and welcomed the new Board members who attended this joint meeting. He had no report and went directly to the other officer reports.

Officer Reports

Secretary's Report: Judi Nikolish asked if there were any comments or questions regarding the November Board meeting minutes that were distributed earlier in the day. There were none and Kris Howard made a motion to approve the minutes as written, seconded by Gary Foster and the motion passed.

Treasurer's Report: Gary reported on CCI's current financials including a few more club member renewals which were deposited. He will email the current 2021 membership roster to members of the Board and also work with Mike Golightly on contacting 2020 club members who have not yet renewed for 2021. All club financial numbers can be found in our Members Only section of the CCI website. Gary's report was moved for approval by Kris, seconded by Judi and the motion passed.

Vice President's Report: Kris had no official report but Kris and Dave offered to assist incoming VP, Kevin McClure as he takes over these responsibilities.

Governor's Report: Denny Luther commented that while COVID-19 negatively impacted our 2020 season, during a recent conference call, NCCC stated that they are planning for a full back-to-normal season for 2021. **Competition Director's Report:** Nichole Parnell had nothing to report but she did question the Board as to how the club might handle Points Awards for the COVID-19 impacted 2020 season.

Member at Large Report: Steve Howard had nothing to report. **Editor's Report:** Dave had no report but stated that he will continue as CCI Editor for 2021. **Points Director's Report:** Wayne Nikolish reported that 100% of all 2020 points have been posted to the club's spreadsheets

and all relevant documentation is ready for audit once the Points Audit Committee is chosen. Wayne will transfer his records to the 2021 Points Director as soon as next year's Governor Gary Foster names that person. **Membership Director's Report:** Mike will reach out to current members who have not yet renewed for 2021. Our membership sits at 96 for 2021. **Social Media Director's Report:** Pat Whalen commented that a number of meetings/dates are already posted to our new website. As we move forward in 2021, Pat may assume the role of Social Media Director.

Old Business: Kris Howard explained some of the issues associated with implementing the new club website. There was additional discussion as to the Webmaster position being eliminated and that function is rolled into the Social Media Director position. It was noted that our club has zero sponsors or advertising moving into 2021 (refocus is required). Moving forward, the club needs to have its own Zoom account (Gary will research). Incoming Secretary Jeff Jackson presented an idea of a CCI specific State of Iowa vehicle license plate (additional discussion to follow). Gary commented on unused 2020 sanction monies paid to the West Region and if those funds can be returned to CCI or used for charitable distribution (Denny will research). Gary stated that 100% of the club's 2020 charitable obligations have been met.

New Business: Gary proposed a recognition award of some sort be presented to Bob Brown Chevrolet in appreciation for their longtime support of the club's Toys for Tots campaign. Nichole said she could assist with this. The next board meeting is Tuesday, January 5, 2021.

A motion to adjourn from Gary was seconded by Denny and the meeting adjourned @ 7:25PM.
